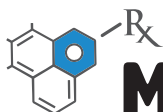
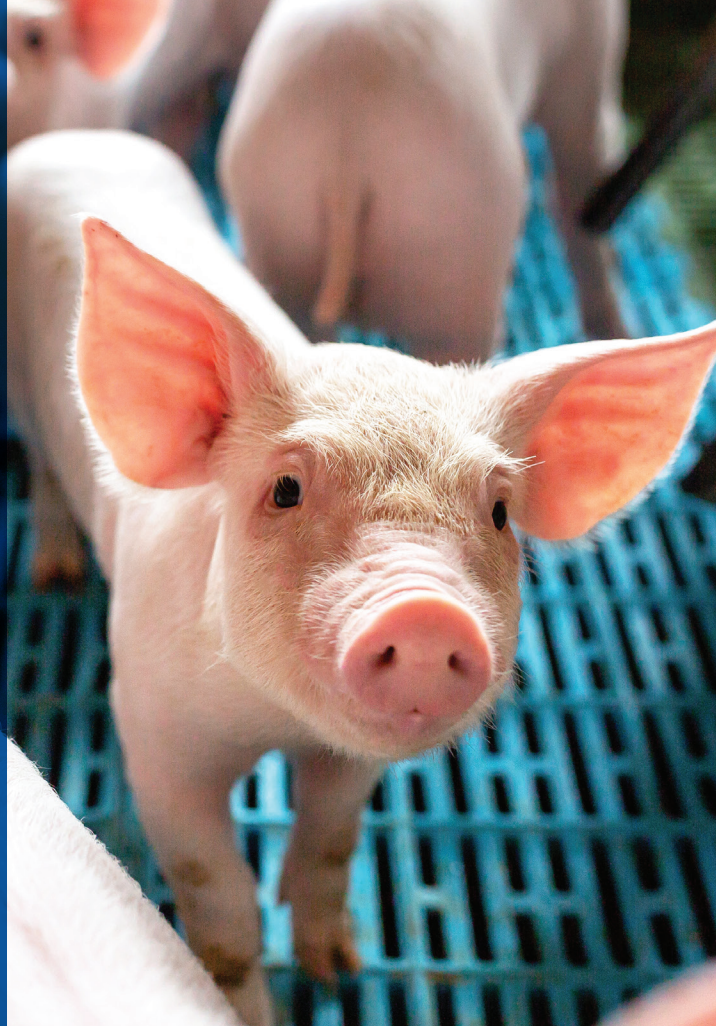




## COMPOUNDED SOLUBLE **MELOXICAM**

Meloxicam is classified as a selective cyclooxygenase-2 (COX-2) inhibiting non-steroidal anti-inflammatory drug (NSAID). It is used for treatment or relief of fevers, pain and inflammation, and it is only available through veterinarian prescription. Meloxicam is available in water soluble and oral drench formulations for flexible administration and targeted dosing.



# MELOXICAM

*Soluble*

- **Concentration:** 0.6% (6 mg/mL)
- **Available sizes:** Pint or gallon
- **Common prescription dosage:**
  - Day 1: Two pints of Meloxicam per five gallons of stock solution
  - Days 2–7: One pint of Meloxicam per five gallons of stock solution
- **Miscibility\*:** UltrAmox™, Tilmicosin, Neomycin, Sulfadiazine/Trimethoprim, Chlortetracycline, Lincomycin, Gentamicin, Iversol™
- **Do not mix with:** Acids, Tylvalosin, Tiamulin

# ADMINISTERING COMPOUNDED SOLUBLE MELOXICAM

Meloxicam is miscible with a large variety of other drugs in the same stock solution, including UltrAmox, Tilmicosin, Neomycin, Sulfadiazine/Trimethoprim, Chlortetracycline, Lincomycin, Gentamicin, Iversol. Mix Meloxicam with other drugs only on veterinarian's prescription.

## BEST PRACTICES FOR USE

- 1 Mix precisely to the ratio directed on the prescription
- 2 Do not exceed total volume called for on prescription
- 3 Add Meloxicam, then water, then mix well with stirring spoon or tool
- 4 Follow duration of treatment per prescription instructions
- 5 Mix Meloxicam with other drugs only on veterinarian's prescription
- 6 Discard old solution and mix new solution daily
